# Priority European integration legislative initiatives



**30%**

all of Ukraine's commitments in agriculture and sanitary and phytosanitary measures are fulfilled  
(696 tasks out of 2259)



**63% and 72%**

progress in 2022 in terms of agriculture (63%) and sanitary and phytosanitary measures (72%)



**+20.5% and +14.7%.**

progress in 2022 in terms of agriculture (+20.5%) and sanitary and phytosanitary measures (+14.7%)

# Land relations

Land reform was launched in 2019

**The reform** is **aimed at** ensuring the exercise of citizens' constitutional rights to freely dispose of their property; formation of capable territorial communities by transferring state-owned agricultural land to them as the main means of production and economic development of the territories; transparent and efficient management of land resources.

**Land reform is implemented by achieving goals:**

- Introduction of a transparent agricultural land market
- transparent and efficient land management

**Key legislative acts adopted:**

**Law of Ukraine dated 31.03.2020 No. 552-IX** "On Amendments to Certain Legislative Acts of Ukraine Regarding the Terms of Turnover of Agricultural Land"

**Law of Ukraine dated 17.06.2020 No. 711-IX** "On Amendments to the Land Code of Ukraine and Other Legislative Acts on Land Use Planning"

**Law of Ukraine dated 28.04.2021 No. 1423-IX** "On Amendments to the Land Code of Ukraine and Other Legislative Acts on Improving the System of Management and Deregulation in the Field of Land Relations"

**Law of Ukraine dated 18.05.2021 No. 1444-IX** "On Amendments to Certain Legislative Acts of Ukraine on the Sale of Land Plots and Acquisition of the Right to Use Them through Electronic Auctions"
